Applications

SCHÖNOX AB is a sheet membrane to be installed using the Rollable Sealing Adhesive SCHÖNOX iFIX® in

- in heavy loaded commercial wet rooms (such as public shower rooms or therapy rooms in hospitals)
- in residential wet areas (bathrooms and showers)
- on balconies, terraces and in swimming pools prior to the installation of ceramic tiles. Approved for pool depth of 32.8 ft. / 10 m using flexible thin sets.

Substrates

SCHÖNOX AB (installed using SCHÖNOX ■ Shelf life: 2 years iFIX®) is suitable on:

- concrete, cement substrates
- gypsum based substrates (compressive strength > 2,500 psi)
- old existing substrates such as ceramic tiles, natural stones and terrazzo
- polystyrene boards coated with mortar
- wall panels of light weight concrete
- plaster
- gypsum board
- after plywood, OSB boards (interior only)
- masonry (fully grouted)
- interior only

Requirements of substrate

- Subfloors must be smooth, sound, clean, dry and free of any contaminants which may hinder adhesion.
- Surface treatments or any "friable" areas of the subfloor must be mechanically removed back to a sound base and the substrate repaired with SCHÖNOX repair compounds as required.
- Old adhesives should be removed

completely. Do not use any chemicals to prepare approved substrates.

- With subsequent laying of ceramic coverings, cement substrates should be at least 28 days old and have a maximum moisture content of 3 lbs./1000 sq. ft/24 hrs. (per ASTM F1869) or 75% RH (per ASTM F2170). Gypsum substrates must always be dry!
- Not recommended over moisture sensitive substrates such as wood or gypsum in exterior areas or commercial wet rooms.
- Do not use over substrates containing asbestos, dimensionally unstable substrates and substrates where hydrostatic pressure conditions exist.
- Old floors such as ceramic tiles should be thoroughly cleaned and abraded.
- The requirements of the relevant valid standards, guidelines and data sheets apply.

■ Install SCHÖNOX AB following the Technical Data Sheet of SCHÖNOX iFIX®.

- Store horizontal in cool, dry conditions avoiding any deformation.
