## Applications

#### SCHÖNOX MULTIFIX is suitable for release bonding of:

- carpet tiles with
  - foam backing, either smooth or embossed - synthetic secondary or jute backing
  - synthetic secondary backing
  - felt backing
- CV coverings (cushioned vinyl)
- impact sound insulation underlays on suitable substrates in interior areas.

## **Requirements of substrate**

- Subfloors must be smooth, sound, clean, dry and free of any contaminants which may hinder adhesion.
- Surface treatments or any "friable" areas of the subfloor must be mechanically removed and the subfloor repaired with SCHÖNOX leveling compounds as required.
- Old water-soluble adhesives should be removed completely, old water-resistant adhesives should be mechanically removed as far as possible. The complete mechanical removal of cutback (i.e. grinding, sanding, blasting) can be hazardous as old cutback adhesive may contain asbestos. Do not sand or grind adhesive residue. Refer to the Resilient Floor Covering Institute's publication "recommended work practice for removal of resilient floor coverings" for instruction. Prime remaining adhesive residues accordingly.
- All slabs on or below grade level must be known to have an intact vapor retarder directly beneath the concrete in conformance to the relevant standards. If in doubt, please contact our SCHÖNOX representative for further advise.
- With subsequent laying of floor coverings on cementitious substrates, where moisture readings are above 85% RH or 6 lbs./1000 sq.ft./24hrs then application of SCHÖNOX MR 18, SCHÖNOX EPA or SCHÖNOX EPA RAPID may be used to suppress residual moisture (see data sheet). Always follow the directions of

the floor covering manufacturer regarding the maximum allowable moisture content and test the substrate prior to installing SCHÖNOX MULTIFIX.

- Gypsum substrates should always be dry. Do not use moisture mitigation systems on gypsum substrates.
- Complete removal of SCHÖNOX MULTIFIX is not guaranteed from open pored coverings such as ceramic tiles, natural stone, wood or linoleum
- Always follow the floor coverina manufacturers guidelines regarding specific substrate requirements for their coverinas.
- The requirements of the relevant valid standards, guidelines and data sheets apply.

#### **Recommended method of** working

- SCHÖNOX MULTIFIX is stirred before use.
- Floor he coverings must always conditioned, unstressed and lav flat without any deformation. Always acclimate the floor coveringaccordingly following the manufacturers guidelines.
- Spread the tackifier evenly on the substrate. Avoid lumps of adhesive. Recommended trowel size: 1/16"x1/16"x1/16" or roller.
- SCHÖNOX MULTIFIX can be diluted with up to 50 % water to reduce adhesion, particularly for carpet tiles.
- Testing of the recommended trowels is essential to ensure a good wetting!
- Textile coverings with synthetic secondary backing are installed during the "semi-wet phase"
- Coverings with a smooth backing are installed during the "contact phase".
- Laving stages:
- "semi-wet phase": early contact phase, glue line domes get transparent, starting stringiness, glue lines still wet.
- "contact phase": adhesive film transparent, but still tacky.
- After fitting the covering without any bubbles, roll the covering using a metal roller. A second rolling should be done if required at a later stage.
- To release the covering and to remove the adhesive from a non-porous substrate: the floor covering is slowly peeled off the substrate. Remove existing adhesive residues with soapy water after a sufficient, ,soaking in time' of approx. 30 minutes. This process may be repeated if required.
- Direct bonding to old adhesive residues can lead to interactions and thus to unpleasant odors.
